DEPOSIT AND WAIVER CONDITIONS

As a small business it is understood that we do not have the employees, infrastructure, or the means of much larger print brokerages to do event estimates or negotiate discounts free of charge where special events are concerned and operate under the structure of an event consultant. As such, we have adopted a means to trade down pricing in exchange for certain considerations. By acknowledging or signing this document, you agree to the basic terms and conditions of providing your entity with services moving forward.

In exchange for estimate research and negotiated pricing above and beyond the normal items (IE: lanyards, badges, banners, and basic signage) we charge as a consultant at:

For shows of 2000 attendees or more - \$500.00 Non-refundable deposit used to schedule your event and cover the first 15 hours of work.

For shows above 1000 attendees but less than 2000 - \$350.00 Non-refundable deposit used to schedule your event and cover the first 10 hours.

Overages are billed as consultation hours at a rate of \$35.00 per hour.

This can be waived in the following manners:

Choose one:

Entrance to the event (if within our travel radius) to distribute our info packets to artists, vendors, and guests. Up to 6 (six) standard admissions are necessary.

The event will agree to receive the info packets by shipping to distribute in our absence to artists, vendors, and guests.

Any entity that is under the size of this agreement, or above the size, that is doing basic services with us, or none at all, where deposits and overages may not apply is agreeing to allow us access to the event to market ourselves in accordance with their event rules. We will advertise our attendance if attending, and where available, may seek to use funds to sponsor portions of the event in a courtesy exchange. This agreement will hold no monetary value except any agreed upon for entrance and will be determined by the value of invoices.

Completing print projects is not a condition of this agreement and this agreement exists outside of that scope. Discounts are defined as lower pricing compared to the events previous years paid or the current market value against online printers such as VistaPrint or 4imprint. We do not warrant or guarantee that we are the lowest priced supplier out there. Deposits may be paid instead of waived. Emunah Graphics LLC will advertise the event, or our attendance, even in the event of not working together for as long as this agreement is valid. If this agreement is used as a waiver of deposit and overages, the entity entering this agrees that if the conditions are not met or upheld by them that a cancellation of terms by either party means they must pay the balance of the waived fees within 7 business days.

Emunah Graphics LLC has the right to terminate this agreement at will, for any reason, for any behavior on the part of the event runners that is hostile, deceptive, malicious, defamatory, fraudulent, or does not comply with the printing and file requirements of this company. The event may terminate this agreement at will for any reason with the understanding that upon termination of this agreement, any outstanding balances will be enforced, and that the event agrees that mediation, court, or legal intervention exists within the jurisdiction of Montgomery County OHIO and no other venue should they refuse to settle their invoices. The event will be responsible for legal fees incurred in any attempt to collect if a judgement is entered in favor of Emunah Graphics LLC.

If marketing items are shipped to your event for distribution, and an amount goes unused, the event will report that amount to Emunah Graphics LLC for instructions. Emunah Graphics LLC may wish to reclaim those items at their own expense and may provide a FedEx shipping number to the event to charge the shipment to or may ask the client to ship inside a small USPS box and a check will be mailed for postage.
