Warp Speed Printing is a small privately owned business that maintains and asserts its right under private ownership to refuse service at its discretion. Warp Speed Printing upholds the First Amendment rights of individuals, but Warp Speed Printing will refuse services in the following instances (and may use its discretion in circumstances not covered under this policy):

1. Copyrights & Intellectual Property:

Customers must represent and warrant that they own the rights, or have obtained the rights, to use any logo, trademark, service mark, artwork, name, photograph, statement, illustration or any other intellectual property to be placed on the products purchased with this company. Emunah Graphics LLC accepts no liability for the unauthorized use of any art, logo, trademark or copyright printed on any item ordered by the customer. If payment has been accepted and Emunah Graphics LLC acted in good faith that the artwork was clear for use, and finds that the artwork was not, all work will be halted, and the payment will be subject to forfeit and no refunds offered. The customer agrees to defend, indemnify and hold harmless Emunah Graphics LLC from any claims, suits or actions alleging that any artwork supplied by the customer violates or infringes the intellectual property rights of any third party.

2. Bullying and Harassment:

This company under no circumstances will print, agree to print, or work with any entity or individual seeking to print items of a bullying or harassing nature. This includes, but is not limited to:

3. Hate Speech:

- a) Text or graphics that can be used to incite violence, fear, panic, or civil unrest towards a community or specific demographic of individuals.
- b) Text or graphics that contain depictions or verbiage against any race, ethnicity, religion, color, immigration status, culture, disability, or deals with cultural appropriation.

4. Political Printing:

Under no circumstances will this company agree to work on or complete any political printing for any political party, political organization or independent. Further, this company will refuse to continue to work with, or work with, any non-profit organization found to be acting outside the scope of its mission to engage in political stances, supporting political stances, or furthering political agendas that exist outside the main function of the organization. This will include any person associated with, or acting on their behalf of, or acting in such a manner on their personal time that it reflects on the non-profits image and be interpreted as the organization's support of an outside cause.

5. Community Harm:

This company will not participate in acts of community harm or social justice. Imagery, texts, or media that negatively impacts community services, law enforcement, military, first responders, or subversive messages against local/state/federal government will not be tolerated. This company reserves and exercises its right as a private entity to take no sides and remain neutral where civil or public unrest applies. This company will work with any law enforcement agency as a witness to any community harm that may be criminal in nature conducted in the presence of one of our agents.
